# PROJECT TRANSFORMATION

## A NEW WORLD OF CARE

### CAPITAL CAMPAIGN WILL BRING SMALL HOUSE TO NEW REHABILITATION CENTER AND OUR HOME

This is an exciting time at Jewish Geriatric Services (JGS) as we update our facilities and expand services to improve health outcomes and enhance resident dignity, independence and quality of life. We call our vision — and the \$9 million capital campaign that will bring it to reality — **Project Transformation: A New World of Care**. It's about a new philosophy, a new architecture, and a new look for the entire organization. Central to the vision is the Small House model of care, which combines the best of a home-like setting with skilled person-centered care, giving residents the freedom to live life on their terms, rather than conform to the rhythms of the institution.

“Our goal is to truly transform how care is delivered, moving away from the traditional medical model of care to a social model where the person cared for is afforded the greatest degree of autonomy, dignity and personal choice,” said Martin Baicker, president and CEO, JGS. “It is called Small House and studies have concluded that residents experience a higher quality of life in almost every area.”

Robert Baevsky, MD, Chair, JGS Board of Directors reflected, “For more than a century JGS has prided

itself on being a progressive, forward-looking organization. We continue to seek solutions to the challenges of aging and embrace new practices. **Project Transformation** continues that tradition.”

Five key initiatives define **Project Transformation**:

- 1) Construction of a two-story 24,000 square foot short-term care Rehabilitation Center in the Small House model, connected to the Leavitt Family Jewish Home by a promenade that will house a Kosher Café
- 2) Conversion of the A-1 and A-2 units of the nursing home into the Small House model
- 3) Significant upgrades and enhancements to Ruth's House
- 4) Additional upgrades and enhancements to the Leavitt Family Jewish Home
- 5) Expansion and relocation of Wernick Adult Day Health Care Center to offer a specialized program for those dealing with dementia and early Alzheimer's Disease

In our new short-term Rehabilitation Center each floor will be a self-contained Small House, designed as a community of 12 individuals. Rehabilitation clients will enjoy private rooms with private bathrooms and residential finishes, furniture and

lighting. Each Small House will offer a central living room, hearth, dining room and kitchen — warm and inviting areas for residents to enjoy and families to congregate, and where rehabilitation can take place as individuals prepare to return home. Our new Kosher Café will service residents, staff, families and visitors, and is also expected to attract the community.

In the nursing home, the A-1 and A-2 units will be renovated into 3 Small Houses (for a total of 6). Each House will accommodate 8 — 10 individuals and be staffed by a self-directed care team to assist residents with daily living activities. These include meal planning, cooking, laundry, personal care, resident-centered activities as well as activities to manage chronic diseases. This model has been shown to foster deeper relationships between residents and staff and an increased sense of security and well-being, in addition to greater staff satisfaction.

Ruth's House upgrades and enhancements are underway — including transformation of our Garden Level porch into a four-season activities area with access to our outdoor gardens. Similar enhancements at the Leavitt Family Jewish Home will upgrade and refresh the Welcome Center, common areas and resident rooms. Wernick Adult Day Health Care will relocate to larger quarters on campus (the site of our former Family Medical Center) and expand to offer a specialized program for those dealing with dementia and early Alzheimer's Disease.

Longtime JGS leaders and volunteers Susan B. Kline and Stephen N. Krevalin are chairing the \$9 million **Project Transformation** capital campaign. Both are passionate about the changes underway. "Our construction of a new and free standing rehabilitation center in the Small House model of care is necessary and will provide improvements to the quality of experience, quality of care, and quality of life of rehabilitation patients," says Krevalin. Adds Kline, "**Project Transformation** donors will see their gifts make an important and lasting difference in the lives of their loved ones and the people we serve."

- Communities of 8 — 12 individuals
- Staffing by self-directed care teams with advanced training
- Private rooms with full bathrooms, opening to a central living area, open full kitchen and dining area (All rooms in our rehabilitation center will be private. Out of a total of 56 rooms in the nursing home renovation, 8 will be retained as semi-private)
- Home-like configuration: front hallway, communal hearth and living room, fireplace, open kitchen with large dining table, family style meals, and cozy den
- Short distances from bedrooms to living areas to encourage walking and reduce need for wheelchairs

## SUSAN B. KLINE AND STEPHEN N. KREVALIN TO CHAIR PROJECT TRANSFORMATION

Leading the campaign to transform care at Jewish Geriatric Services are two special individuals, each with an impressive resume of involvement, volunteerism and support at JGS and in the general community. Susan B. Kline and Stephen N. Krevalin bring years of experience and passion to their commitment to our plans to bring person-centered care and the Small House model to JGS.

Susan was an active family member at Ruth's House, helping to raise awareness of assisted living at JGS and to raise funds to support staff advancement through our clinical ladders program. She co-chaired our Future Vision Task Force, developing a strategic plan to take JGS into our second century of care and leading to our current **Project Transformation** initiatives and the embracing of the Small House model of care. She has served on several JGS committees and was Chair of the JGS Board from 2012 – 2014, exciting years as the organization celebrated its centennial. Volunteerism and giving back to the community comes naturally to Susan. Among her many

leadership positions she is a Past President of Kodimoh Synagogue as well as The Jewish Federation of Western Massachusetts, and the current director of the Create A Jewish Legacy Program at the Harold Grinspoon Foundation. A communications consultant, Susan provides writing and speaking training to employees of companies throughout our region.

Kline is enthusiastic about the campaign's benefit to the community and the people we serve. "We have asked ourselves how we can serve everyone in our care the best possible way, seeing the whole person and respecting their independence, their dignity and their right to the highest quality of care. The Small House model will do just that, transforming traditional views of care in every way. Donors will be able to see the direct results of their contributions."

Stephen Krevalin's connection to JGS goes back generations. He followed his parents, grandparents and aunts and uncles as an involved and active member on numerous committees. Steve was the Chairman of the Jewish Nursing Home from 1992—1996 and then was elevated to Chairman of Jewish Geriatric Services for two consecutive terms spanning 1996 – 2000. At that time, he oversaw the successful implementation of our Regeneration Campaign which made possible

## JUDE RABIG LENDS SMALL HOUSE EXPERTISE TO PROJECTS

Jewish Geriatric Services has secured the consultative advice of Jude Rabig, PhD to assist in the design and implementation of Small House at JGS. Rabig is a nationally recognized expert on culture change and the Small House model of deinstitutionalized nursing home care.

Rabig has a deep understanding of organizational change and its application to long-term care. As the first Director of the Robert Wood Johnson-funded National Green House® Project, she designed the operating model, authored and delivered the training curriculum, and created materials for the replication initiative. Jude has presented and published widely on small house and culture change. She is a nurse gerontologist, a former Atlantic Philanthropies, Hartford Foundation Practice Change Fellow; and a Center for Medicare and Medicaid Services Innovation Adviser.

She holds a PhD in gerontology and a business certificate from Stanford School of Business. She is also the Director of NASH, The National Alliance of Small Houses.

Rabig, who has created plans for over 20 Small Houses commented, "There is no one-size-fits-all solution to long term care challenges. I am excited to partner with JGS to develop a Small House model that will successfully deinstitutionalize care, respecting that elders are unique, holistic beings who deserve care rooted in understanding each individual and his or her particular needs. That is what person-centered care is all about. Indeed, after nurses transition and adjust to the Small House model, they typically say, "This is what I went into nursing to do — care for people."

## REMEMBERING CHUCK WOLFE

*Mentor, Colleague and Friend*

This past September the JGS community was deeply saddened by the news of the sudden passing of a dear friend, colleague and advisor Chuck Wolfe, a larger-than-life personality who served JGS for 20 years.

Our friendship and collaboration began in 1994 with the planning of our Regeneration Campaign. In large part because of his capable guidance, JGS succeeded in not only meeting, but exceeding our \$6 million goal, raising \$7.5 million! Chuck was much more than a fundraising consultant; he was a mentor, a colleague and a friend. He taught us all to think outside the box. He was both a realist and an eternal optimist. His attention to details ensured success. He brought a refreshing sense of humor and levity to situations...a gift of seeing the larger picture and keeping things in perspective.

Chuck knew our community as if it were his own. Such familiarity bred sound advice. He helped develop a strategy and materials for our 1998 JGYES! Campaign, consulted on our 2012 Centennial Campaign, and most recently lent his enthusiasm and insight into **Project Transformation**. He brought to JGS a wealth of knowledge, passion and vision in eldercare services having served as the CEO of the Mount Sinai Medical Center Foundation in Miami for 5 years, the CEO of Jewish Home for the Aged of Detroit for 16 years, and as a Past President of the North American Association of Jewish Homes & Housing for the Aged.

"Chuck was far more than a fundraising consultant; he saw the larger issues and influenced our strategic planning and resource development. In the short time we worked together, Chuck became a close colleague and friend," reflected Marty Baicker, CEO of JGS. "Chuck was a true Renaissance man, with a wealth of experience and knowledge and an incredible spirit of generosity."

Stephen Krevalin, Co-Chair of our **Project Transformation** Campaign reflected, "I am forever grateful and consider myself incredibly lucky and blessed for having had the wonderful experience of friendship and mentorship and to have collaborated with Chuck. It is hard to quantify or even qualify the impact that one person has on another, but I know that in many ways how I go through life has been forever changed by my knowing and learning from Chuck. JGS is deeply saddened by the loss but we are committed to continuing Chuck's legacy as we move forward with our project, with the confidence that Chuck instilled our foundation for success."

A resource for the entire community, Chuck provided his counsel to other local Jewish organizations including the Jewish Community Center and Lubavitcher Yeshiva Academy. Michael Paysnick of the JCC described Chuck as, "smart, wise and motivating...with a softer side as well: I was most appreciative of his reaching out to me when I first became executive of the JCC to offer his encouragement and ongoing counsel." Rabbi Kosofsky of LYA reflected that Chuck, "had a unique sixth sense to cut to the core of an issue. In the more recent years, Chuck was searching for a stronger connection to the foundation and meaning of Judaism. He joined my family for Friday night dinner and his presence enhanced our Shabbat table. I consider it a privilege and an honor to have known Shimeon, Chuck Wolfe."

Chuck's close camp friend Lenny Newman recited at Chuck's funeral, "Some people come into your life and quietly go... Some stay for awhile and leave footprints on your heart."

Chuck left many footprints on our hearts and in our minds. We will forever be asking each other, "What would Chuck say?" and because of his good mentoring, we will come up with the answer. Chuck left us too early, but he left us with a solid vision and plan. He has left an everlasting footprint on JGS and our community and we are all the better for it.
